

7. The applicant/Environmental Assessment Practitioner ("EAP") is required to inform this Department in writing upon submission of the draft report to the relevant State Departments. Upon receipt of this confirmation, this Department will in accordance with Section 24(2) & (3) of NEMA inform the relevant State Departments of the commencement date of the 30 day commenting period.
8. Unless otherwise indicated by the Department, a commenting period of at least 21 (twenty-one) days must be provided to I&APs, including the relevant State Departments, to comment on any additional information, documentation or reports (including the final EIR), other than the draft EIR.
9. The applicant/EAP must record and respond to all comments received. The comments and responses must be captured in a **Comments and Responses Report** and must also include a description of the public participation process followed and this report must also be included in the public participation information to be attached to the final EIR. The final EIR must be made available to registered I&APs for comment before it is submitted to the Department for consideration.
10. Good environmental practice encourages you to engage with State Departments in the pre-application phase or early in the EIR process to solicit their inputs on any of their requirements to be addressed in the EIR process. Please note that this does not substitute the requirement of making the draft EIR available to State Departments as stipulated above.
11. Two printed copies, as well as one electronic copy (saved on CD/DVD) of the EIR must be submitted to the Department.
12. You are hereby required to submit an Environmental Management Programme ("EMP") together with the EIR to the Department to meet the requirements of 24G(1)(vii)(ee) and section 24N of the NEMA. The EMP must address the potential environmental impacts of the activity throughout the project life cycle, including an assessment of the effectiveness of monitoring and management arrangements after implementation (auditing). **The EMP must be submitted together with the EIR.**
13. When compiling the EIR you must take into account the applicable guidelines developed by the Department, which may be downloaded from the Department's website (see above). In particular the following:
- 13.1. Guideline for Environmental Management Plans (June 2005);
 - 13.2. Guideline on Public Participation
 - 13.3. Guideline on Need and Desirability
14. Consideration must be given to ways which would minimise waste and wastage in the design, construction and operational phase of the development. In this regard please see the Department's Waste Minimisation Guideline for EIA Reviews (May 2003), available from the Department on request. The Guideline raises awareness to waste minimisation issues and highlights waste and wastage minimisation practices.
15. The EIR must be submitted to the Department within a period of **6 (six) months** from the date of issue of this letter.
16. If you are not able to submit the EIR within the six month period, you must timeously inform the Department as such **before** the end of the six month period by submitting a comprehensive motivation why the EIR will not be submitted within the six month period. The motivation must include the tasks that have been performed to date, the reasons for the delay in submission and an indication on which date the EIR will be submitted to the Department.
17. The Department will consider your motivation and inform you of its decision whether or not to continue with the processing of the current application. **Should no motivation be provided, your section 24G application file will be referred for law enforcement or criminal investigative action.**
18. Furthermore, you may be issued with a directive to comply with any such provision in terms of section 24G of the NEMA that this Department may deem necessary. The following directives in terms of section 24G(1)(b) has reference:

Directorate: Environmental Governance

- (i) Immediately cease the activity pending a decision on the application submitted in terms of this subsection;
- (ii) Investigate, evaluate and assess the impact of the activity on the environment;
- (iii) Remedy any adverse effects of the activity on the environment;
- (iv) Cease, modify or control any act, activity, process or omission causing pollution or environmental degradation;
- (v) Contain or prevent the movement of pollution or degradation of the environment;
- (vi) Eliminate any source of pollution or degradation;
- (vii) Compile a report containing the conditions as stipulated in section 24G(1)(b)(vii); and
- (viii) Provide such other information or undertake such further studies as the Minister, Minister responsible for mineral resources or MEC, as the case may be, may deem necessary.

19. You are reminded that it is an offence in terms of section 49A of the NEMA to commence with a listed activity unless the competent authority has granted environmental authorisation for the undertaking of the activity and it is an offence for person who fails comply with a directive issued in terms of NEMA. A person convicted of an offence is liable to a fine not exceeding **R10 million** or **imprisonment for a period not exceeding 10 years**, or to both such fine and imprisonment.
